### I) Highlights

The Division of Dermatology has continued to be a very busy place for both clinical care, consultations, residents and medical students instruction. New and advanced therapeutic techniques available in the Division has included, microdermabrasion, photo dynamics therapy for the treatment of skin cancer, photo dynamics therapy for the treatment of acne vulgaris and new innovated surgical techniques for facial reconstruction and rejuvenation.

### **D-** Teaching Activities

Visiting physicians from other hospitals in the province of Quebec have attended teaching activities where they have been instructed in tissue reconstruction for the aging skin. The approximate number of students attending electives this past year has been approximately 40.
