Annual Report Division of Rheumatology April 1, 2005 - March 31, 2006

We continue to ditrect research projects at McGill in early inflammatory arthritis and in Canada we direct the Canadian Scleroderma Research Group. We have also been very involved in devloping programs for musculoskeletal teaching for residents internal medicine.

Under the direction of Dr Baron, the Canadian Scleroderma Research group has submitted and presented multiple abstracts in its first year. Manuscripts are under preparation and several grant applications have been submitted. Similalry, we have been very active in our research projects in early inflammatory arthritis. We have been working on a large project in cooperation with Drs Looper, Zelkowitz and Purden concerning the role of family distress in our patient group and have submitted and presented multiple abstracts.

Laeora Berkson continues to be supported by the Arthritis Society Clinician Teacher Award. In this capacity, she has been developing and delivering a rheumatology curriculum for the internal medicine trainee. In 2005-2006, the curriculum was converted from a site (hospital)-specific series of seminars to a McGill-wide series of six half-day educational sessions. There will be eight half-day sessions in 2006-2007.

Dr. Marie Hudson will join our staff in October 2006. She has completed post-doctoral training in epidemiology and will be doing research in several areas including scleorderma.

We would like to expand to 4 full-time rheumatologists. The heavy clinical load requires this if we are to continue our academic activities. To this end we are in the process of designing new space to accommodate 4 full-time rheumaotlogists and multiple clinical research assistants. Fund raising will be necessary to cover all the costs of this expansion.
